YOU ARE ABLE TO SEARCH USING NAME OR RECORDING INFORMATION. SEARCHING BY LAND, OR ADDRESS IS NOT AVAILABLE FOR THIS COUNTY.

TO PERFORM A NAME SEARCH, YOU WILL NEED TO USE THE FOLLOWING FORMAT:

LASTNAME, FIRSTNAME (THIS IS THE PERSON'S LAST NAME, A COMMA, A SPACE, THEN THE FIRST NAME)

EXAMPLE: SMITH, GENE

YOU CAN ALSO SEARCH BY NAME FOR A BUSINESS. YOU DO NOT USE THE COMMA OR SPACE.

EXAMPLE: FIRST NATIONAL BANK

YOU CAN ALSO USE A “%” AS A WILDCARD. FOR EXAMPLE, IF YOU KNOW THE PERSONS LAST NAME, AND NOT SURE ABOUT THE FIRST NAME.

EXAMPLE: SMITH, G%

THIS SEARCH WILL GIVE YOU RESULTS OF ANYONE THAT HAS THE LAST NAME OF SMITH, AND THE FIRST NAME STARTS WITH A “G”.
