

# **CANAAN TITLE SOLUTIONS, LLC - TERMS OF USE**

## **AGREEMENT BETWEEN YOU (referred to as the "User" or "You") AND CANAAN TITLE SOLUTIONS, LLC (referred to as "Canaan")**
